# City of Santa Barbara Background

- Prior to that date we dabbled in using a telephone / PA system interface to allow for remote public comment. We had 1 phone line. Only used twice when a councilmember was in South Africa and when one was in China. So they could participate in the meetings.

- Limited time frame to Implement
- Technology and staff training






City of Santa Barbara Meeting Evolution

- Full Hybrid with all 16 of our televised Council and Boards and Commission meetings
- Hybrid with Masks, no partitions
- Back to Normal

#### Highlights - Staffing Challenges

- Fotal authorized:142 Sworn/ 73 Professional Staff
- >Vacancies Sworn: 24/142 = 16.5%
- >Vacancies Professional Staff: 20/73 = 27.4%
- ➤Total vacancies: 44 = 20.5%

- Started our exploration into Hybrid/Virtual meetings using Go To Webinar.
  Log Me In product
- Based in Goleta. They reached out to us. They had staff assigned to co-host our early meetings to help us through the bumps and to teach our staff how to host meetings.
- Eventually went with Zoom for better accessibility and system reliability.
- Now hybrid meetings and using zoom for remote public testimony and for remote participation among staff, consultants and councilmembers and board and commission members is here to stay.
